

#### **Potential locations**




In conjunction with Essex FA and the Football Foundation, two potential locations have been identified, both of which will be considered in the feasibility study.




#### Indicative funding

The Football Foundation is the main source of funding to help communities improve their local football facilities across England.

The Foundation typically fund 55-60% of a project with the balance coming from the Club and other funders.

Estimated total cost in the region of £500,000. The Club will need to contribute in the region of £30,000 through fund raising.
